- 1) The bidder should have a minimum of 5 year experience in Civil & Interior works at least a 300 bedded hospital.
- 2) The bidder should have a annual turnover of Rs 50 lakhs in each of the last three financial years.
- 3) The bidder firm should be registered as per law (Private LTD, Partnership firm/ Proprietary firm) and must have a valid GST & PAN Certificate.
- 4) The bidder should have experience of successfully completing, One similar work in the last 5 years with a minimum value of Rs 50 lakhs.
Or
Two similar works in the last 5 years with a combined contract value of minimum Rs 75 lakhs.
Or
Three similar works in the last 5 years with a combined contract value of minimum Rs 1 Crore.
